

# Boarding/Daycare Contract

Whiskers Resort and Pet Spa agrees to care for and exercise my pet in a reasonable manner. My pet is to be fed properly and regularly, and is to be housed in clean and safe quarters.

All pets are boarded and cared for by the current Staff of Whiskers Resort and Pet Spa without liability for loss or damage from disease, death, running away, theft, fire, injury to persons/other pets, or property by said pet, or other unavoidable causes when diligence and care have been exercised.

If a pet, which is presented for boarding/daycare, is found to have fleas and/or ticks, they will be treated accordingly at the owners expense.

The pet is not to be taken off the premises unless there has been written and signed consent of the owner.

If a pet becomes seriously ill, the owner shall be notified and the stated veterinarian will be contacted. If the owner does not immediately inform Whiskers Resort and Pet Spa regarding measures to be taken, or if the state of the pet's health demands quick action, Whisker's Resort and Pet Spa reserves the right to call the veterinarian of choice. Whiskers Resort and Pet Spa will then transport the pet to the appointed veterinarian in either case. Medication or other advisable attention, within the discretion and judgment of the appointed veterinarian, and any expenses incurred, being reasonable in amount shall be paid promptly by the owner of the pet.

If any charges for boarding, grooming, daycare, medicine or veterinary services are not paid for within 10 days after the date of departure, or if said pet is not called for within ten days after the expected date of departure, the pet will be considered abandoned, giving Whiskers Resort and Pet Spa full rights to sell, adopt, or turn over to the shelter, publicly, privately, or otherwise. Notice in writing of such intentions shall be mailed by registered mail to the owner of the pet at the address on record, within ten days. No further notice shall be deemed necessary. Any charges incurred due to such intentions as stated above will be given to the owner of said pet.
